She provided a detailed drawing showing the fence boundaries and landscaping upgrades. Discussion followed. It was proposed to expand the scope of work to fence all of the park grounds as opposed to just the spray area. As well as to install recycled water sprinkler system. Advice was also given on obtaining funding and permits. **MOTION:** Dan made a motion to approve the expanded scope of work and the project as a whole, PJ seconded. Motion carried, all in favor.

Nicole Vasquez President of the Kelso Soccer Club reported that there is a tree hanging over the property in the parking area at Monasco Park. She also asked if the City would consider putting in more lights.
