Minutes: Upon motion by Councilmember Harvey, seconded by Councilmember Alexander, 'Approve the Minutes of the 11/15/22 Regular Meeting and the 11/15/22 Special Meeting.' Councilmembers Page, Lefebvre, Harvey, Alexander, and Wood voted yes. Councilmember Hill voted no. Motion passed, 5 to 1.

PUBLIC HEARING:

Final Hearing of the 2023-2024 Biennial Budget (Continued from December 5, 2022 Special Meeting): Finance Director/City Clerk Brian Butterfield briefed the Council on the biennial budget.

At 6:18 p.m., Deputy Mayor Lesebvre opened the public hearing. There were four citizens from the audience that spoke to the budget hearing.

There being no further comment from the public, Deputy Mayor Lefebvre closed the public hearing at 6:25 p.m.

Interlocal Agreement – 2019 NPDES Phase II Stormwater Permit Source Control Requirements, City of Longview: Community Development Director/City Engineer Mike Kardas briefed the Council on the agreement. Discussion followed. Upon motion

by Councilmember Harvey, seconded by Councilmember Hill, 'Authorize the City Manager to execute the Interlocal Agreement with the City of Longview.' Motion passed, all voting yes.

<u>Discussion – Developing a Student Transitional Housing Program:</u> Councilmember Hill spoke about assisting the professional agencies and entities that are specialized to help students in need. Councilmember Harvey spoke about his proposed program. Lengthy discussion followed. Upon motion by Councilmember Harvey, seconded by Councilmember Alexander, 'Direct the City Manager to meet with all entities available to potentially develop this program.' Discussion followed. Councilmembers Lefebvre, Harvey, and Alexander voted yes. Councilmembers Hill, Page, and Wood voted no. Motion failed, 3 to 3.

Motion passed, all voting yes.

Ordinance No. (1st Reading) Amending KMC Title 13.09 Stormwater Management: The Deputy Clerk read the proposed ordinance by title only. Upon motion by

Councilmember Hill seconded by Councilmember Harvey, 'Pass on 1st reading, 'AN ORDINANCE OF THE CITY OF KELSO, WASHINGTON AMENDING CHAPTER 13.09 OF THE KELSO MUNICIPAL CODE TO ADD SOURCE CONTROL REQUIREMENTS FOR EXISTING DEVELOPMENTS.' Motion passed, all voting yes.

Ordinance No. (1st Reading) Imposing an Additional Sales Tax relating to the Transportation Benefit District: The Deputy Clerk read the proposed ordinance by title only. There was no motion made.
