Scott asked Randy about the wire theft at Rister. The City is required to get three bids. It may be covered by the City insurance. Bob will look into the league insurance. Busack Electric quoted around \$2855. Scott will provide boulders to Tim to cover the electric boxes to prevent future theft.

3. Park Board Comments

South Kelso Neighborhood Association (SKNA) is looking to remove the old kitchen area at Tam O and replace with a newer covered area perhaps with restrooms.

Bob asked about the cell tower repairs to the gravel and sidewalk. Tim is still trying to coordinate a time for repair and receive a valid commitment. He will contact the company again. Scott suggested that we give them one last opportunity to do the work or we will and bill them for it.

Bob asked about the broken elevator at Rister. Removing the elevator and replacing it with an ADA ramp would not be cost effective due to the extreme length it would need to be to meet requirements. The issues with the repairs is that they are reoccurring and unpreventable because it should never had been installed outside as it is not weatherproof. From a safety standpoint it should be removed. Bob will contact the mill elevator repair people to see if they have better options.

Bob made a motion to adjourn the meeting, Jerry seconded. Motion carried, all in favor. Meeting adjourned at 6:28 pm.
