#### Call to Order:

Chair Rick VonRock called the meeting to order at 6:02 pm.

#### Minutes:

Commissioner Graves made the motion, seconded by Commissioner Webb to approve the minutes of April 21, 2015. Motion carried, all in favor.

Commissioner Graves made the motion, seconded by Commissioner Webb to approve the minutes of April 14, 2015. Motion carried, all in favor.

**Public Hearing:** Planning Consultant Gregg Dohrn provided the commission with a history of the Washington State Shoreline Management Act including the Act's goals, policies, jurisdiction, and applicability to Kelso. He provided background on Kelso's current Shoreline Master Program, the update process, and the major components of the Program including the shoreline environmental designations, table of permitted uses, permitting process, mitigation sequencing requirements, buffers, and regulations governing new and expanded uses and developments. He concluded his presentation with an overview of the next steps in the adoption process and the role played by the State and Department of Ecology.

There was discussion regarding specific development and maintenance activities, definition of terms, and the Commission's role in reviewing the proposed documents.
